Mix concentrate up to 1:128	1 ounce cleaner per gallon
with water in scrubber tank.	of water.

HEAVY CLEANING:	DILUTION RATE
Mix concentrate up to 1:32 with	4 ounces degreaser per
water in scrubber tank.	gallon of water.

Do not exceed 4 ounces per gallon of water dilution. If increased soil removal is needed explore additional brush / pad changes.

#### **AUTOMATIC SCRUBBING**

Dilute the High Alkaline Degreaser using the following dilution rates depending on the level of soilage:

Light Cleaning: Mix 1 oz of High Alkaline Degreaser per gallon of water.

**Heavy Cleaning:** Mix 4oz of High Alkaline Degreaser per gallon of water.

Partially fill solution tank with water. Pour the required amount of High Alkaline Degreaser slowly into the solution tank. Fill the solution tank with water until the level is just below the indicator level. Once the solution tank is filled with the appropriate dilution rate, scrub the floor according to the machine manual.



#### **MANUAL SCRUBBING**

Warning! Wear rubber or other impervious gloves and splash goggles when handling.

Warning! Follow appropriate floor safety procedures.

Dilute the High Alkaline Degreaser using the following dilution rates depending on the level of soilage:

Light Cleaning: Mix 1 oz of High Alkaline Degreaser per gallon of water.

**Heavy Cleaning:** Mix 4oz of High Alkaline Degreaser per gallon of water.

Once the High Alkaline Degreaser is dilute, apply to the floor and scrub with a manual floor scrubber. Pick up solution with a mop or wet vacuum.

 In federally inspected meat and poultry plants, always follow soilage pickup with a potable water rinse.
